

Richard Petty Motorsports and Click N' Close™ Garage Makeover Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: Richard Petty Motorsports and Click N' Close™ Garage Makeover (the "Sweepstakes") is open only to legal residents of the fifty (50) United States and the District of Columbia and are at least eighteen (18) years old at the time of entry.** Employees of Mid America Mortgage, Inc., National Association for Stock Car Auto Racing, Inc. 3. Timing: The Sweepstakes begins on February 5, 2018 at 12:00 a.m. Eastern Time ("ET") and ends on April 30, 2018 at 11:59 p.m. ET (the "Promotion Period"). NASCAR's servers are the official time-keeping device for the Sweepstakes.

4. How to Enter: During the Promotion Period, visit <http://clicknclose.nascar.com> and follow the links and instructions to complete and submit the registration form including entrant's name, valid email address, and valid home address. P.O. Boxes are not permitted. You automatically will receive one (1) entry into the Sweepstakes. Limit: You may enter one (1) time during the Promotion Period. Multiple entrants are not permitted to share the same email address. **By entering the Sweepstakes, entrants agree to receive email marketing from Sponsor and NASCAR. Entrants may unsubscribe at any time without impacting their Sweepstakes entry.** Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each potential winner may be required to show proof of being an authorized account holder.

5. discretion. All details about the content, features, and colors of any upgrades or changes included in the garage makeover will be determined by Sponsor in its sole discretion after consultation with the Winner. Winner will be asked to refrain from publicizing any content of the makeover through any channel until the makeover is complete. To the extent that winner does not cooperate with Sponsor's request for access to his garage and home or any other requests related to completion of the makeover, winner will forfeit the prize. Sponsor reserves the right to substitute a prize for one of equal or greater value if the designated prize should become unavailable for any reason. Limit: One (1) prize per person. Total ARV of all prizes: \$15,500. First and Second Prizes will be fulfilled within approximately 8-10 weeks after the conclusion of the Sweepstakes. Sponsor will initiate planning and discussion of garage makeover within 6-8 weeks of winner confirmation.

Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to
